Recommendations:

- 1. Administrators must carefully monitor attendance in the four on-campus courses required in the Applied Science degree in Criminal Justine online program which were clear deterrents to past student retention. (CFRs 4.1, 4.2)
- 2. Prior to implementation of the proposed program, course syllabi must be revised to provide specific course schedules, assignments, technology resources and course and institutional policies. (CFR 2.12)
- 3. Staff assigned to the preparation of future WSCUC proposals must be knowledgeable about WSCUC expectations for adhering to format, document access and technology needed for proposal completion. (CFR 1.8)
- 4. Academic Administration must carefully monitor and ensure the reasonable workload for the designated Criminal Justice Program Coordinator. (CFR 3.2)
- 5. Academic Administration is strongly advised to develop protocol and scheduled activities required of adjunct faculty to discuss and ensure shared understanding of Program Learning Outcomes. (CFRs 2.1, 2.3, 2.7, 3.1, 3.3)
- 6. The Institution must establish and formally approve a full teach-out policy in accordance with WSCUC standards which is published for access by students and faculty. (CFRs 1.4, 1.5)
- 7. Any materials used to promote the program in advance of WSCUC approval must clearly state "pending WSCUC approval." (CFRs 1.3)
